With configurations allowing for up to 8 seats and available in 2 lengths, the PEUGEOT Traveller adapts to your needs.

The second and third rows consist of a 2/3 split bench seat - the 2 sections are independent of each other and can slide on their rails to easily adjust rear space.

Sliding and removable seats allow you to adapt the space for all situations. By fading down the front passenger seat, the PEUGEOT Traveller can also carry loads of up to 3.50 m in length\*.

The PEUGEOT Traveller also offers numerous storage

compartments adding up to 49 litres of space distributed throughout the passenger cabin.

With the Standard version, at only 4.95 m long, 8 people can still be accommodated with ease. For a boot volume of 1700 litres, simply remove the third row seats, on Long versions this increases to 2,100 litres.

Putting the seats back is straightforward. Just return them to their rails and adjust their position.

## TECHNOLOGY and safety

For a safer and more comfortable drive, the PEUGEOT Traveller has a large number of latest generation driving aids.

### 180° Colour Reversing Camera\*

The reversing camera\* is automatically activated when the driver selects reverse gear. It provides a 180° aerial view of the rear zone of the vehicle and its surroundings. The rear view includes guidance lines which turn with the steering wheel. When there are obstacles behind the vehicle, the system automatically zooms in, in addition to providing other views on request.

## Speed limit recognition and intelligent speed adaptation\*\*


The multifunction camera\* recognises speed limit signs and displays the relevant limit on the instrument panel or in the head up display. The detected speed limit is suggested as the value to be used in your cruise control or speed limiter, if they are activated.

### Automatic Emergency Braking System (AEBS2)\*

The Automatic Emergency Braking System (AEBS2)\* is a new generation automatic emergency braking system which is activated if a collision is about to take place. The camera and radar detect moving or stationary obstacles. If the brakes are not applied, or if the driver does not brake hard enough, the system brakes for them. It can prevent the impact if the speed is below 18mph, or reduce the result of the collision above this speed, by reducing the speed of impact.



### PEUGEOT Smartbeam Assistance^

Activated at night, the system automatically controls the switch between main beam and dipped headlamps, and vice versa, when oncoming vehicles are identified by the camera.

## Adaptive cruise control\*

This system allows you to maintain a safe distance between you and the vehicle in front, by changing the speed of your vehicle by up to 12mph. It is not an active braking system. This system works particularly well in moving and relatively heavy traffic.

## Lane Departure Warning System^

An alert detects if solid or broken white road markings are crossed unintentionally, when the indicator is not activated. The audible and visual alert is particularly useful if the driver becomes drowsy or loses concentration.

## Blind Spot Monitoring System\*

Thanks to the 4 sensors located on the front and rear bumpers of your vehicle, the blind spot monitoring system\* lets you know if a vehicle is present in your left or right hand side blind spot, during your journey. A light appears in one of the door mirrors or on the screen as a warning.

### Head-Up Display\*

The Head-Up Display projects the information essential to driving onto a retractable screen located in the driver's field of vision: speed, cruise control or speed limiter setting, etc. All the information you need is right in front of your eyes, ensuring a safer driving experience.



### Airbags

The PEUGEOT Traveller is equipped up to 6 airbags:

- 2 front and side airbags to protect the head and chest of the driver and the passenger in the event of a frontal impact
- 2 curtain airbags\*\* to protect the driver and the front passenger in case of side impact





#### Official Fuel Consumption in MPG (I/100km) and CO<sub>2</sub> emissions (g/km) for the PEUGEOT Traveller range are: Combined 35.5 (8.0) – 47.1 (6.0) and CO<sub>2</sub> 152 - 126 g/km.

The fuel consumption you achieve, and CO<sub>2</sub> produced, in real world conditions will depend upon a number of factors: including the accessories fitted (post registration), variations in weather, driving styles and vehicle load. There is a new test (WLTP\*) used to measure fuel consumption and CO<sub>2</sub> figures. The fuel consumption figures shown in this advert are calculated under the WLTP test. The CO<sub>2</sub> figures shown are NEDC equivalent (NEDCeq), calculated using EC correlation tool which converts WLTP figures to NEDC figures, however, these NEDCeq figures are based on the outgoing test cycle (NEDC\*\*) and will be used to calculate tax for first registration. Figures shown are for comparability purposes; you should only compare fuel consumption and CO<sub>2</sub> figures with other vehicles tested using the same technical standard.
