



PEUGEOT FRIENDS AND FAMILY TERMS AND CONDITIONS

The Promotion is subject to the following terms and conditions (the "**Terms**") between you ("**You**") and Peugeot Motor Company, with a registered address at Pinley House, 2 Sunbeam Way CV3 1ND. ("**Peugeot**").

TERMS AND CONDITIONS

1. The Promotion is available on select models of new Peugeot Passenger cars only (the "**Qualifying Vehicle**").

2. The Promotion is a discount of up to £2,000 towards the on-the-road (OTR) price of new Peugeot passenger cars only (the "**Promotion**"). The maximum discount that may be applied for each model and affinity partner is as follows:
